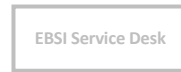

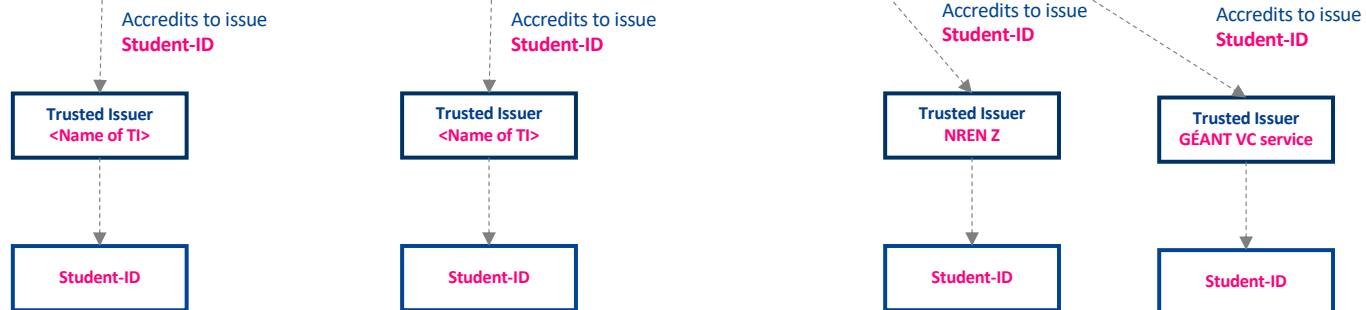


Set up trust chain for **Student-ID (MyAcademicID)**
