This page describes the current practice of federations with regard to upstream and downstream metadata publication. Upstream Approaches:

- Full Opt-in.
- Full Opt-out.
- IdP Opt-in, SP Opt-Out.
- IdP Opt-out, SP Opt-in (**Recommended**)

Downstream Approaches:

- Everything in local feed.
- Choose local or local+interfederation.
- Separate1 (all).
- Separate2 (IdP, SP).
- Separate3 (all,IdP, SP).
- Consume directly from MDS. (**Not recommended!**)
- Custom.
